What is this product?

Type: Shares of a Sub-Fund of MULTI UNITS FRANCE, a UCITS (Undertaking for Collective Investment in Transferable Securities), established in the form of an SICAV.

Term: The Sub-Fund has an unlimited duration. The Management Company may dissolve the Fund by means of liquidation or merger with another fund in accordance with legal requirements.

AMF classification: French equities

Objectives: The fund is a passively managed, index-based UCITS.

The objective of the Fund management is to replicate, both upwards and downwards, the performance of the CAC 40 Gross Total Return Index (gross dividends reinvested) (the "Benchmark Index"), denominated in euro (EUR) and representative of the shares of the 40 largest companies listed on Euronext Paris while keeping the tracking error between the performance of the Fund and that of the Benchmark Index to a minimum..

The expected level of the tracking error under normal market conditions is indicated in the Fund's prospectus.

The Euronext website (www.euronext.com) provides more detailed information on Euronext indices.

The Fund aims to achieve its objective by means of direct replication, namely by primarily investing in an asset pool formed of securities comprising the Benchmark Indicator and/or the financial instruments representative of all or part of the securities comprising the Benchmark Indicator.

In order to optimise the replication of the Benchmark Index, the Fund may use a sampling technique in addition to collateralised temporary sales of securities.

Any use of these techniques is indicated on the website amundiETF.com.

The updated composition of the securities portfolio held by the Fund is mentioned on the website amundiETF.com.

In addition, the indicative net asset value appears on the Reuters and

Bloomberg pages of the Fund and may also be mentioned on the Fund's stock exchange websites.

The Fund is eligible for the French Equity Savings Plan (Plan d'Epargne en Actions français, or PEA) and therefore invests a minimum of 75% of its assets in European Union company shares.

Intended retail investors: This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds, seeking to increase the value of their investment over the recommended holding period and who are prepared to take on a high level of risk to their original capital.

The product is not open to residents of the United States of America/"U.S. Person" (the definition of "U.S. Person" is available on the Management Company's website www.amundi.fr and/or in the prospectus).

Redemption and transaction: The Sub-Fund's shares are listed and traded on one or more stock exchanges. Under normal circumstances, you can trade shares during stock exchange trading hours. Only authorised participants (e.g. selected financial institutions) can trade shares directly with the Sub-Fund on the primary market. Further details are provided in the MULTI UNITS FRANCE prospectus.

Distribution policy: In accordance with the prospectus, net income and capital gains from sales may be capitalised or distributed at the discretion of the Management Company.

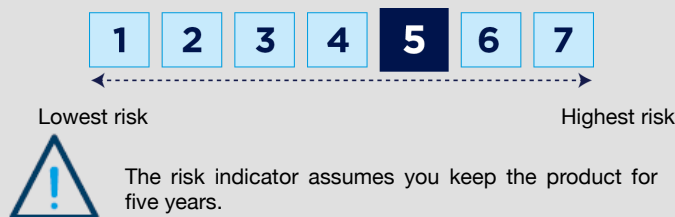

What are the risks and what could I get in return?

RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movement in the markets or because we are not able to pay you.

What happens if Amundi Asset Management is unable to pay out?

What are the costs?

How long should I hold it and can I take money out early?

Recommended holding period: Five years is based on our assessment of the risk and reward characteristics and costs of the sub-fund.

This product is designed for medium-term investment; you should be prepared to stay invested for at least 5 years. You can redeem your investment at any time, or hold the investment longer.

Order schedule: Redemption orders must be received by 05:00 French time on the Valuation Date. Please refer to the MULTI UNITS FRANCE prospectus for more information about redemptions.
