## What is this product?

**Type:** Shares of a Sub-Fund of Amundi Index Solutions, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

**Term:** The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

**Objectives:** This Sub-Fund is passively managed. The objective of this Sub-Fund is to track the performance of SHORTDAX Index, and to minimize the tracking error between the net asset value of the Sub-Fund and the performance of the Index. The anticipated level of the tracking error, under normal market conditions, is indicated in the prospectus of the Sub-Fund.

The Index, which is calculated by STOXX Ltd., is tied to the performance of the German blue chip DAX® index (Performance Index) (the "Base Index") and tracks at index level the performance of an investment with a short position in relation to the DAX® Index. The DAX® Index calculated by STOXX Ltd. comprises the 40 largest German companies with the highest turnovers that are listed on the Frankfurt Stock Exchange. The Index is a Total Return Index : the coupons paid by the Index constituents are included in the index return. More information about the composition of the index and its operating rules are available in the prospectus and at: [stoxx.com](http://stoxx.com) The Index value is available via Bloomberg (SHORTDAX).

The Sub-Fund will apply an Indirect Replication methodology to get exposition to the Index. The Sub-Fund will invest into a total return swap (financial derivative instrument) delivering the performance of the Index against the performance of the assets held. Derivatives are integral to the Sub-Fund's investment strategies.

The Sub-Fund's shares are listed and traded on one or more stock exchanges. In normal circumstances, you may deal in shares during the trading hours of the stock exchanges, provided that the Market Makers can maintain market liquidity. Only authorised participants (e.g. selected financial institutions) may deal in shares directly with the Sub-Fund on the primary market. Further details are provided in the prospectus of the UCITS.

**Intended Retail Investor:** This product is intended for investors, with an average knowledge of and some experience of investing in funds, seeking to increase the value of their investment over the recommended holding period with the ability to bear losses up to the amount invested.

**Redemption and Dealing:** The Sub-Fund's shares are listed and traded on one or more stock exchanges. In normal circumstances, you may deal in shares during the trading hours of the stock exchanges. Only authorised participants (e.g., selected financial institutions) may deal in shares directly with the Sub-Fund on the primary market. Further details are provided in the Amundi Index Solutions prospectus.

**Distribution policy:** The Fund's amounts available for distribution (if any) will be distributed.

## What are the risks and what could I get in return?

### RISK INDICATOR



The risk indicator assumes you keep the product for 3 years.

### What happens if Amundi Luxembourg S.A. is unable to pay out?

The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.
