What is this product?

Type: Shares of a Sub-Fund of MULTI UNITS LUXEMBOURG, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: The Fund is an index-tracking UCITS passively managed.

The investment objective the Sub-Fund is to track both the upward and the downward evolution of the MSCI Europe Climate Action Net Total Return Index (the "**Index**"), denominated in Euros, while minimizing the volatility of the difference between the return of the Sub-Fund and the return of the Index (the "**Tracking Error**").

The anticipated level of Tracking Error in normal market conditions is indicated in the prospectus of the Sub-Fund.

The Index is based on the MSCI Europe Index (the "**Parent Index**") and is representative of the performance of large and mid-cap stocks, across developed European countries, issued by companies that have been assessed to lead their sector peers in terms of their positioning and actions relative to climate transition, based on, among others, the MSCI "Climate Risk Management Weighted Average Score", while minimizing the volatility of the difference between the return of the Index and the return of the Parent Index.

The Sub-Fund promotes environmental and/or social characteristics through among others, replicating an Index integrating a Climate Risk Management Score. The Index methodology is constructed using a "Best-in-class approach". More detailed information on MSCI ESG Rating methodology can be found on the following link: [msci.com](https://www.msci.com)

Limits of the methodology of the Index are described in the prospectus of the Sub-Fund through risk factors, such as the market risk linked to controversies and the risks linked to ESG methodologies and to ESG score computation.

The Index is a net total return index: dividends or distributions net of tax paid by the Index constituents are included in the Index return.

The Sub-Fund seeks to achieve its objective via a direct replication, by investing primarily in the securities comprising the Index. To optimize the Index replication, the Sub-Fund may use a sampling replication strategy. In order to generate additional income to offset its costs, the Sub-Fund may also enter into securities lending transactions. Intended Retail Investor: This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment over the recommended holding period with the ability to bear losses up to the amount invested.

Redemption and Dealing: The Sub-Fund's shares are listed and traded on one or more stock exchanges. In normal circumstances, you may deal in shares during the trading hours of the stock exchanges. Only authorised participants (e.g., selected financial institutions) may deal in shares directly with the Sub-Fund on the primary market. Distribution policy: The Fund's amounts available for distribution (if any) will be distributed.

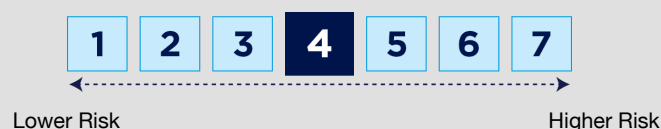

What are the risks and what could I get in return?

RISK INDICATOR



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movement in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

What happens if Amundi Luxembourg S.A. is unable to pay out?

The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

What are the costs?

How long should I hold it and can I take money out early?

Recommended holding period: 5 years is based on our assessment of the risk and reward characteristics and costs of the Sub-Fund.

This product is designed for long-term investment; you should be prepared to stay invested for at least 5 years. You can redeem your investment at any time, or hold the investment longer.
